Personal contacts (telephone calls, letters, e-mails, or post cards) to your legislators will count towards this award only if reported to the Michigan PTSA Vice President for Legislative Activity. Include the date of communication, who was contacted and the subject of the communication.

Earn additional points by copying responses from your elected officials and sending them to the Vice President for Legislative Activity.

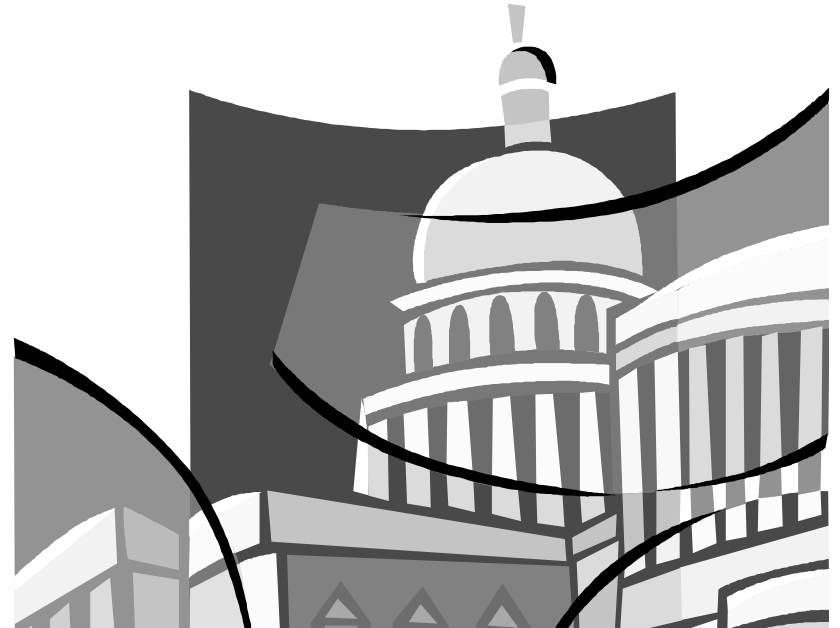
